- 7:10 Review/approve the April 8 minutes
 - April 2020 board meeting minutes were approved.
- 7: 15 Any concerns with Committee/Team Reports?
 - A motion was made to ratify the appointment of Peter Hartranft as our member-atlarge board member. The motion was unanimously approved.
- 7: 20 Report from the Treasurer: **Proposed 2020/2021 Budget**, P&L, Balance Sheet
 - Glen reviewed the draft budget that was prepared by the Finance Committee.
 - A motion was made to reduce the budgeted UUA dues from \$11,000 to \$6,000;
 The motion passed with one abstention and one nay vote.
 - A motion was made to reduce the \$18,000 budget for the auction to \$13,000 (reduction of \$5,000); the motion passed with one nay vote.
 - Glen made a motion to approve the draft budget; the board unanimously approved the draft budget with the two changes that were approved (mentioned above).
 - Glen proposed a hearing meeting on the proposed budget (at the end of May).
 This meeting will be scheduled shortly.

7:30 Old Business

- June 14 Congregational Meeting: agenda, voting
 - The plan is to keep this meeting relatively simple. The congregation needs to vote on Peter Hartranft as new Member-at-Large, Winter Congregational Minutes, and the 2020-2021 Proposed Budget. Don will plan to give an overview of this year and thoughts on the future year.
